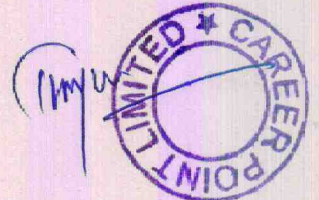
1. Considered and approved Standalone and Consolidated Unaudited Financial Results (Statement) for the quarter and half year ended September 30, 2015.
